# Revolutionary business model for the Modern Affiliate & Modern Networker

## INTRODUCTION

The MAKE Wellness Pay Plan is the first of its kind designed to cater to the modern affiliate and the modern networker. The plan is made up of two primary income pathways: personal production sales and helping others be successful with MAKE Wellness.

MAKE Wellness Affiliates earn commissions on the sales from the customers and Affiliates on their team. Commissions are based on the sale amount of an order, after discounts, coupons, and product credits are applied and excludes shipping, taxes and fees.

Affiliates begin accumulating sales volume on the first day of each month, continuing through the last day of the month. The total sales volume generated by an Affiliate, along with their customers and team members, determines their qualification and payout.

Commission payments are processed daily and monthly depending on the bonus type.\* This is especially exciting - any order completed by 11:59 PM MT, is paid out the following day! It's an excellent way to quickly reap the rewards of your efforts. Monthly commission payments are made by the tenth of each month for the previous month's sales.

#### RECOGNITION

At Make Wellness we take pride in recognizing our amazing Affiliates! One of the ways we do this is by acknowledging Affiliates based on achievements within the Make Wellness Pay Plan. An Affiliate will be referred to by their highest achievement for recognition, but will be compensated at the level they achieve each month.

The Premier Affiliate achievement is central to the MAKE Wellness Pay Plan. As you learn more about each bonus type, you'll see why striving to qualify as a Premier Affiliate each month is an essential goal.

## **CIRCLE SALES BONUS**

The Circle Sales Bonus rewards Affiliates for their personal production. The more you sell, the higher the percentage you earn on your total Circle Sales volume, up to 40%! In addition to cash commission, you can earn up to \$200 in product credit, each month.

#### What is included in Circle Sales volume?

- 1. Your personally referred customer's orders and any customer orders they refer.
- 2. Orders from Affiliates you personally refer, we call these individuals Direct Affiliates.
- 3. Your purchases. To earn a commission on your purchases, you must qualify as a Rising Affiliate or higher.

To be qualified to earn commission, you must have at least one \$50+ order in your Circle Sales from a customer or Direct Affiliate. \*

To be eligible to earn product credits, you must have your own subscription order of \$100 or more in the month.

An Affiliate can count no more than \$500 in personal orders toward their Circle Sales qualification and can only earn commissions on up to \$500 of personal orders.

#### **Circle Sales Guaranteed Earnings**

The Rising Affiliate, Senior Affiliate, and Premier Affiliate titles each come with a guaranteed minimum earning, ensuring you receive a set amount just for reaching the milestone. At Rising Affiliate, you're guaranteed \$100, at Senior Affiliate \$200, and at Premier Affiliate \$500.

Here's how it works: If, at the end of the month, your calculated earnings fall below the guaranteed amount for your achieved title, the difference is covered in your monthly commission. For example, if you achieve Premier Affiliate with \$2,000 in sales, the 20% commission rate would earn you \$400. However, because of the \$500 guarantee for Premier Affiliates, an additional \$100 would be paid to ensure you receive the full guaranteed amount.

Circle Sales volume is calculated monthly and paid each business day to Affiliates. Daily commission payments are based on the percentage you qualify for at the time the commission is processed. If you achieve a higher qualification after the commission has been paid, the difference will be paid the next time commissions are processed. Product credits are applied to your MAKE Wellness shopping account on the same day the monthly commissions are paid.

## **Circle Sales Luxury Rewards**

Earn up to \$10,000 towards luxury gifts for achieving top Circle Sales titles.

When an Affiliate achieves Premier 30K or higher for the first time, they are eligible for a luxury gift card reward of their choice from select brands. Circle Sales Luxury Rewards are awarded annually at the Make Wellness conference during the awards show.

Circle Sales Luxury Rewards terms and conditions: The Circle Sales Luxury Reward is a non-transferable, non-cash reward that has no cash value and cannot be substituted or exchanged. To qualify, an Affiliate must be in good standing at the time of the award and must attend the annual Make Wellness Conference. Failure to meet these conditions will result in forfeiture of the reward with no compensation provided. This program is subject to change at any time.

## **MAKE MOMENTS**

At Make Wellness, we are dedicated to helping you create moments that truly matter. Create an unforgettable experience when you qualify for a \$500 Make Moments Gift Card.

Affiliates are eligible to earn a \$500 Make Moments Gift Card when they qualify as a Premier Affiliate in their first full calendar month with Make Wellness. A first full month is considered the first day of the month through the last day of the month. For example if an Affiliate joined on June 4th, they would have all of June or all of July to meet the requirements. If an Affiliate joined on June 1st, they would have all of June to meet the requirements.

Make Moments gift cards are issued after the commission month has closed. To receive the gift card, the Affiliate must be in good standing at the time of mailing. If this requirement is not met, the gift card will be forfeited with no compensation provided.

#### **TEAM OVERRIDES**

Supporting your team members' growth is one of the most fulfilling aspects of being a modern Affiliate with Make Wellness. Beyond the excitement of being part of a dynamic community of like-minded entrepreneurs, it offers the chance to thrive in a collaborative culture while also creating opportunities to earn additional income.

# **AFFILIATE DEVELOPMENT BONUS**

The Affiliate Development Bonus rewards you for supporting and helping your Affiliate teams grow. While you earn on your Direct Affiliate's sales through the Circle Sales Bonus, the Affiliate Development Bonus applies to the other Affiliates and customers within your organization.


You begin earning the Affiliate Development Bonus when you qualify as a Premier Affiliate. Tap into deeper pay when developing other Premier Affiliates on your team. A Premier Qualified Team is formed when either your Direct Affiliate or another Affiliate on their team qualifies as Premier or higher.

#### **Tiers**

At MAKE Wellness we organize your business into pay tiers.

Tier 1 starts with your Direct Affiliate's customers and the first Affiliates referred by your Direct Affiliates. It continues down to and includes the first qualifying Premier Affiliate. Tiers 2–6 each includes the sales volume from Affiliates starting after the previous qualifying Premier Affiliate down to and including the next qualifying Premier Affiliate.



## **TOTAL TEAM BONUS**

As you develop Premier Affiliates and grow your total team sales, you can earn cash bonuses added to your monthly commission earnings through the Total Team Bonus. Bonuses range from \$500 to \$100,000!

To qualify for the Total Team Bonus, you need to qualify as a Premier Affiliate. Your bonus level is determined by your total team's sales volume, the number of Premier Affiliates on your team, and the number of Premier Qualified Teams in a month.

As you achieve higher levels of the Total Team Bonus, not only does your cash bonus increase, but you will be recognized with each new achievement.

The Total Team Bonus is calculated and paid monthly.

# **SALES VOLUME ADJUSTMENT**

The Sales Volume Adjustment is designed to allow Make Wellness to offer a lucrative and attractive opportunity for the Modern Affiliate and Modern Networker. While sales volume is paid at 100% through Circle Sales, the volume is adjusted for payout through the Affiliate Development Bonus. The adjustment varies based on the commission percentage paid on an order through the Circle Sales Bonus.

Sales Volume Adjustments do not apply to the Total Team Sales for qualification purposes.

## **FOUNDERS BONUS**

The Founders Bonus is an exciting opportunity to earn additional commissions while building Make Wellness during its founding year! You can earn up to \$103,000 in additional commissions with this bonus.



To be eligible, you must be a Premier Affiliate and join by March 31, 2025.

Qualified Affiliates are eligible to earn Founders Bonuses The promotion ends March 31, 2026.

Bonuses are stackable, so if you qualify at a higher level and have not yet received payment for lower-level bonuses, you will be paid all eligible bonuses you qualify for.

To receive all payments at each level, you must requalify for the Founder's Bonus. For example, to earn all four payments for the 150K Visionary Bonus, you must achieve 100K Visionary four times during the qualification period.

The Founder's Bonus is calculated and paid monthly.
